Notice of transfer of insurance cover to TAL Super Policy Number:

You currently have insurance cover provided through the TAL Superannuation and Insurance Fund (**TSIF**). Effective on 31 July 2017, we will transfer your cover to TAL Super, a plan in the Mercer Super Trust (ABN 19 905 422 981) (**MST**). From this date, you will cease to be a member of the TSIF and your right to claim a death or disability benefit from TSIF will also cease.

What does this mean for your insurance cover?

The transfer will not adversely affect the terms and conditions of your insurance cover. Importantly, the benefit(s), sum(s) insured and premiums provided under your policy will remain unchanged; as will your policy number, the way you pay premiums, and the way you can make a claim. Please note if you have a 'Superlinked Insurance' policy, this policy will also remain unchanged.

From 1 August 2017, where we refer to 'the Fund' or 'the Trustee' in correspondence about TAL insurance provided under the new arrangements, those references will be to TAL Super and Mercer Superannuation (Australia) Limited (ABN 79 004 717 533, AFSL 235906) (**MSAL**).

About TAL Super and MSAL

TAL Super was established in the Retail Division in the MST on 1 April 2017. MSAL is the trustee. You can find out more about TAL Super and MSAL online at www.tal.com.au/talsuper. You will receive an Exit Statement from the TSIF and an updated Policy Schedule shortly after the transfer is completed. We have enclosed a Product Disclosure Statement (**PDS**) for TAL Super.
